- (1) Draft the demand letters within 24 hours of receipt of instructions.
- (2) Prepare the Plaint within 48 hours of a decision to file suit by the client.
- (3) File the suit immediately the notice period has elapsed.
- (4) Aggressively pursue the matter in the Courts to ensure early hearing dates.
- (5) Where Judgment is entered in favour of the creditor, we pursue warrants of execution immediately.
